1. Guarantee Coverage

The Breeder guarantees the above-referenced puppy to be free from life-altering genetic or hereditary conditions for a period of two (2) years from the date of adoption.

This guarantee applies specifically to a diagnosed, life-altering genetic or hereditary condition. It does not cover common illnesses, parasites, injuries, or conditions caused by improper care, nutrition, accidents, or environmental factors.

2. Adopter's Responsibilities

The Adopter agrees to provide the puppy with proper lifelong care, including, but not limited to:

- A clean, safe, and nurturing environment
- A nutritious and appropriate diet
- Routine veterinary care
- Age-appropriate vaccinations and preventative care
- Prompt veterinary attention when illness or injury is suspected

3. Claim Process

If a life-altering genetic or hereditary condition is suspected within the two-year guarantee period, the Adopter must:

- Notify the Breeder in writing immediately following the initial diagnosis.
- Provide a written statement and complete medical report from a licensed veterinarian confirming the diagnosis of a life-altering genetic or hereditary condition.

The Breeder reserves the right to obtain a second opinion from a licensed veterinarian of the Breeder's choosing, at the Breeder's expense.

4. Resolution Options

If the claim is validated and the genetic or hereditary condition is confirmed by a licensed veterinarian, the Adopter may choose one of the following options:

Option A: Replacement Puppy

The Adopter may receive a replacement puppy of equal value from the Breeder's next available litter.

The Adopter is responsible for all transportation and related costs associated with receiving the replacement puppy.

Option B: Refund

The Adopter may receive a full refund of the original puppy purchase price.

5. Exclusion and Limitation of Liability

This guarantee is limited to the terms stated in this agreement.

It does not cover veterinary expenses, medications, diagnostic testing, treatment costs, transportation, travel, loss of income, or any other expenses incurred by the Adopter.

The Breeder's total liability is limited to either:

- A replacement puppy of equal value; or
- A refund of the original puppy purchase price

as outlined in Section 4.
